Eligibility: Open to all DSA swimmers who have not qualified for more than 1 individual events for DSA Championships.

Exception: A swimmer who has qualified for one (1) DSA Championship event may swim in this meet, but they may not swim the event they will swim at DSA Championships. This meet is open to all Delmarva Swim Association registered swimmers who are registered as of July 1, 2021 and will swim the age of the swimmer as of May 31, 2021.

Rules: Applicable DSA Swimming rules shall govern this competition. USA SWIMMING/MD SAFETY GUIDELINES AND WARM-UP PROCEDURES WILL BE IN EFFECT FOR THE ENTIRE MEET.

Entry Information:

Times: Entry times must be in short course yards. "No Time (NT)" entries are acceptable. Swimmers may enter up to four (4) individual events plus two (2) relays.

Fees: \$5.00 per individual event, \$20.00 per relay.

All entries must be received by 6:00 PM on July 18, 2019.

All entries must be submitted by email using Hitek's file electronically.

Payment for all email files must be received by July 18, 2021 at 6 PM. As soon as the files have been received through email, the Playtpi will consider them official.

However, if payment is not forwarded by July 25, 2021, HFY reserve the right to reseed swimmers from other teams. Teams entering with less than 10 swimmers can submit written entries on computer entry forms or via email.

Deck seeds and deck registrations will be permitted, and the fee is \$10.00 to be paid before swimmer may compete.

The Meet Director reserves the right to limit entries.

Awards:

Ribbons will be awarded for 1st through 10th place.

Heat winner will be awarded to each heat winner.

Results:

Meet results will be posted on line @ www.delmarvaswim.org. An electronic copy of results will be provided to all teams who send entries or supply the jump drive at the meet. Results will be emailed to all teams 24 - 48 hours after the meet has completed. Hard copies are available on request and will be mailed upon request.

Concessions:

Programs will be sent out to coaches the day before meet and there will be no snack bar at the meet. It is highly suggested to bring drinks and snacks for your kids.

Covid: Due to Covid restrictions, families are not permitted in the building to watch the meet. Families are encouraged to bring tents to set up in the soccer field. Chairs are highly suggested as well. Please come ready to swim. Restrooms will be available in the hot pool for families. Clerk of course will be outside in the back. Once swimmers have completed swimming they are required to exit the facility.

Directions: From West: Proceed east on Business Route 50 (do not take the new bypass) to light at Beaglin Park Dr. Turn Right onto Beaglin Park Dr. Proceed to fourth light (Schumaker Dr.) (Firehouse is on the corner.) Turn right onto Schumaker Dr. Proceed ½ miles. YMCA is on the right.

From North: via Route 13, going south on Route 13, just past Arby's, take Route 13 by-pass (signs to Norfolk), not business 13. Follow Route 13 to Route 50. Take Route 50 West towards Salisbury. After

Phillip Morris Drive, take the next possible left turn onto Beaglin Park Drive. Proceed to fourth light (Schumaker Dr.) (Firehouse is on the corner.) Turn right onto Schumaker Dr. Proceed ½ miles. YMCA is on the right.
