

36th Annual 2007 Kent Invitational Swim Meet

Rules

1. Open to all bona fide members of the invited organizations or clubs.
2. Swimmers may enter a maximum of three (3) individual events and the one (1) relay event.
3. Events are established for two (2) classes of entry:
 - A. OPEN: Entries opened to experienced swimmers.
 - B. NOVICE; Limited to swimmers who have not previously completed in any summer or winter swim team program.
4. Age Qualifications: The swimmer's age as of May 31, 2007 will determine the age in which they may compete.
5. All events are timed finals.
6. Awards:
 - A. Open: Trophies are awarded for 1st, 2nd, and 3rd places; medals are awarded for 4th, 5th, 6th, 7th, and 8th places.
 - B. Novice: Medals are awarded for 1st, 2nd, and 3rd places; ribbons are awarded for 4th, 5th, 6th, 7th, and 8th places.
7. For each event that a swimmer enters, please complete the enclosed "Entry Form" with the swimmer's name, age, event number, and seeding time (in meters). The Kent Swim Team will print cards for each swimmer according to this listing. Information must be legible.

Seeding: Available times submitted will determine the seeding of swimmers (the time must be in meters). Please note: If no time is submitted with an entry, if it is not legible, or if it is submitted incorrectly for any reason, seeding will be done by lots, after proper timed entries are scheduled. They will NOT be adjusted at the start of the meet. The Clerk of Course will not make any exceptions.

Deck Seating There will be NO DECK SEATING FOR THIS MEET.
8. Entry Fee: \$3.50 for each entered event excluding the relay, which is free. NOTE: Each team must make out one (1) check for all their entries. This is a fee not a donation. Please make the check payable to Kent Swim Team.
9. Parental Authorization Slips, Entry Forms, and Entry Fees Must Be Submitted Together by a Team Representative on or Before June, 30, 2007.
